

Boucher, SRA Third Director, Region VI to discuss honoring a local appraiser in the Washington, DC area. This led to a dinner meeting with the son of the potential honoree, Richard R. Harps, CRE, MAI, FRICS.

The dinner meeting was engaging and informative as Richard shared stories of the barriers his father had to break through in pursuit of entering the appraisal industry.

One of the things I have learned over this year in providing solutions to increasing diversity is that representation matters. I remember learning about Harps & Harps as an African-American woman entering the field in the early 2000s. The father and son duo operated a commercial appraisal and litigation firm for over 47 years. Harps was the first Black man to earn the MAI designation. Harps was the first African-American President of the AIREA, a predecessor organization to the Appraisal Institute in 1981. I am also in great company as Harps was the first African-American President of AIDC as I conclude the year as the first African-American Woman President of the AIDC chapter. I am pleased to announce the official name of the Fund is The William S Harps Emerging Leaders Fund.

The creation of The Harps Fund is one of my proudest accomplishments and represents a full circle moment.
