Named in honor of National Past President William S. Harps, MAI, William served as an AI instructor and contributor to educational materials, and paved the way for others to enter the field. He was an entrepreneur, innovator and visionary and

The most important legacy that Mr. Harps left was his dedication to breaking down racial barriers. AIDC is committed to continuing that legacy and removing barriers of entry that have traditionally impacted women and minorities.
